This application must be returned to the Village Office accompanied by the permit fee. Check or money order made payable to the Village of Saltaire may be delivered in person or mailed to:

NOTE: ALL BOATS ON THE BAY BEACH THAT ARE NOT REGISTERED BY APRIL 30th EACH YEAR WILL BE IN VIOLATION OF §14 OF THE VILLAGE CODE AND WILL BE TAGGED FOR REMOVAL FROM THE BAYFRONT. THE OWNER OF THE BOAT WILL HAVE UNTIL MAY 15th TO CORRECT THE VIOLATION BEFORE THE BOAT IS REMOVED TO A VILLAGE STORAGE FACILITY. AFTER THAT DATE, THE OWNER MUST PAY A DAILY STORAGE FEE OF \$10 PER DAY BEFORE THE BOAT IS RELEASED. IF THE OWNER DOES NOT CONTACT THE VILLAGE BY JUNE 30 OF THAT YEAR THE VILLAGE WILL DISPOSE OF IT.

1. Boats 15 feet or less in length that are beached on the bay front area will be charged a \$55 fee except that the fee for a catamaran sailboat is \$102. Mooring from the beach is not permitted.
2. Owners of boats equipped with motors are required to have proof of liability insurance as described on page 1.
3. To encourage the use of bay front space for active sailors, owners of boats that are stored on the bay front but not launched at any time from May through October will be charged a \$165 summer storage fee.
4. Those using the bulkhead cuts for beaching **MUST KEEP CUTS CLEAR.**
5. No catamarans may be beached in the bayfront cuts; they may be beached between the Main Dock and the West Dock on the east side of the marina shore.
6. The permit sticker issued for beached boats must be displayed on the port bow.
7. Village permit stickers must be displayed on all boats beached on the bay front. Boats without permit stickers after July 1 will be removed to the utility area.
8. Applicant agrees that the Village of Saltaire, its trustees and employees, and each of them (the "indemnites"), will not bear any responsibility, or be liable, for damages or any other expense on account of loss from wrongful death, personal injury or property damage of any kind or for any reason whatsoever arising out of the subject beaching permit. Applicant agrees to indemnify the indemnites and to hold them harmless from and against any and all claims, causes of action, costs and expense caused by or arising out of the use of the subject beaching permit.

NOTE: ALL BOATS ON THE BAY BEACH THAT ARE NOT PROPERLY REGISTERED WILL BE IN VIOLATION OF §14 OF THE VILLAGE CODE AND WILL BE TAGGED FOR REMOVAL FROM THE BAYFRONT. THE OWNER OF THE BOAT WILL HAVE UNTIL OCTOBER OF EACH YEAR TO CORRECT THE VIOLATION BEFORE THE BOAT IS REMOVED TO A VILLAGE STORAGE FACILITY. AFTER THAT DATE, THE OWNER MUST PAY A DAILY STORAGE FEE OF \$10 PER DAY BEFORE THE BOAT IS RELEASED. IF THE OWNER DOES NOT CONTACT THE VILLAGE BY NOVEMBER 30TH THE VILLAGE WILL DISPOSE OF THE BOAT.

1. Boats 15 feet or less in length that are beached on the bay front area will be charged a \$50 fee except that the fee for a catamaran sailboat is \$75. Mooring from the beach is not permitted.
2. Owners of boats equipped with motors are required to have proof of liability insurance as described on page 1.
3. Those using the bulkhead cuts for beaching **MUST KEEP CUTS CLEAR.**
4. No catamarans may be beached in the bayfront cuts; they may be beached between the Main Dock and the West Dock on the east side of the marina shore.
5. The permit sticker issued for beached boats must be displayed on the port bow.
6. Village permit stickers must be displayed on all boats beached on the bay front. Boats without permit stickers after July 1 will be removed to the utility area.
7. Applicant agrees that the Village of Saltaire, its trustees and employees, and each of them (the "indemnitees"), will not bear any responsibility, or be liable, for damages or any other expense on account of loss from wrongful death, personal injury or property damage of any kind or for any reason whatsoever arising out of the subject beaching permit. Applicant agrees to indemnify the indemnitees and to hold them harmless from and against any and all claims, causes of action, costs and expense caused by or arising out of the use of the subject beaching permit.
