LOCAL LAW NO. OF 2016 OF THE VILLAGE OF SALTAIRE A LOCAL LAW AMENDING CHAPTER 47 SECURITY AND CODE ENFORCEMENT TO CHANGE THE TITLE OF SECURITY TO PUBLIC SAFETY.

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF SALTAIRE AS FOLLOWS:

3.0 Severability and Validity

Section 1.0 Title, Enactment, Effective Date and Purpose.

1.1. Title

This Local Law shall be entitled, "Local Law No. of 2016: A Local Law Amending Chapter 47 to Change the title of Security to Public Safety".

1.2 Enactment.

Pursuant to Section 10 of the Home Rule Law, the Village Law and the Village Code of the Incorporated Village of Saltaire, the Incorporated Village of Saltaire, County of Suffolk and State of New York, hereby enacts by this Local Law No. of 2016, a Local Law of the Incorporated Village of Saltaire.

1.3. Effective Date.

This local law shall take effect on the filing of the approved Local Law with the Secretary of State of New York, which shall be within twenty (20) days after its approval by the Board of Trustees of the Incorporated Village of Saltaire.

1.4. Purpose and Intent of Local Law.

The purpose and intent of this local law is to change the title of Security in the Village of Saltaire to the title of Public Safety in order to properly characterize the services and duties of Public Safety in the Village of Saltaire.

2.0 General Provisions.

2.1 Public Safety Department.

The department of the Village of Saltaire known as the “Security Department” shall hereinafter be entitled and known as the “Public Safety Department” of the Village of Saltaire, and all references to “Security”, “Security Department”, and or “Security officers” presently contained in Chapter 47 of the Saltaire Village Code shall be amended to respectively refer to “Public Safety”, “Public Safety Department”, and “Public Safety Officers”.

2.2 Amendments to Chapter 47 Security and Code Enforcement of the Saltaire Village Code.

Chapter 47 Security and Code Enforcement of the Saltaire Village Code is hereby amended as follows:

A. The title of Chapter 47 is hereby amended to “Chapter 47 Public Safety and Code Enforcement”.

B. The language of the references to “Security Department” in Section 47-1, Section 47-2, Section 47-3, Section 47-4, Section 47-5(A), is hereby amended to read “Public Safety Department”.

C. The language “Security force” in Section 47-2 is hereby amended to read “Public Safety Department”.

D. The language “Security officers” in Section 47-4 is hereby amended to read “Public Safety officers”.

3.0 Severability and Validity

3.1 In the event that any portion or section of this Local Law may be determined to be invalid, the remaining portions and sections of this Local Law shall remain in full force and effect.
