EXECUTIVE ORDER OF A
DECLARATION OF A LOCAL STATE OF EMERGENCY

Pursuant to Section 24 of the Executive Law

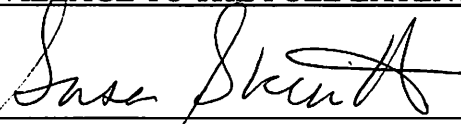
PLEASE TAKE NOTICE, THAT EFFECTIVE 12:00 P.M. DST , SEPTEMBER 25, 2026, THE HONORABLE SUSAN SKERRITT, MAYOR OF THE VILLAGE OF SALTAIRE, HEREBY DECLARES A LOCAL STATE OF EMERGENCY IN THE VILLAGE OF SALTAIRE DUE TO THE POSTED NOR'EASTER STORM ADVISORIES AND WARNINGS IN EFFECT FOR THE GREATER METROPOLITAN AREA, AND THE EXPECTED UNSAFE DRIVING AND BOATING CONDITIONS AND POSSIBLE CANCELLATION OF FERRY SERVICE AND LOSS OF ELECTRICAL SERVICE EXPECTED FROM THE EVENING OF SEPTEMBER 25, 2026, THROUGH THE NIGHT OF SEPTEMBER 27, 2026, AND BASED ON A DETERMINATION BY ME THAT THE PUBLIC SAFETY AND SAFETY OF THE EMPLOYEES AND OFFICIALS OF THE VILLAGE AND THE PUBLIC WOULD BE IMPERILED BY IN- PERSON ATTENDANCE AT A PUBLIC MEETING OF THE BOARD OF TRUSTEES SCHEDULED TO BE HELD AT 103 BROADWAY, SALTAIRE AT 8:30 A.M. ON SEPTEMBER 26, 2026, AND THAT THE IN-PERSON ATTENDANCE AT THE MEETING BY VILLAGE STAFF AND THE BOARD AND PUBLIC WOULD BE UNSAFE DUE TO THE CIRCUMSTANCES STATED IN THIS DECLARATION, THEREBY RESULTING IN THIS DECLARATION OF A LOCAL STATE OF EMERGENCY; IT IS THEREFORE:

ORDERED THAT AS THE MAYOR AND CHIEF EXECUTIVE OF THE VILLAGE OF SALTAIRE, DUE TO THE FORECAST OF SEVERE WEATHER IN EFFECT RESULTING IN THE DECLARATION OF THE LOCAL STATE OF EMERGENCY, PURSUANT TO THE POWERS PERMITTED BY SECTION 24 OF THE NEW YORK STATE EXECUTIVE LAW, AS OF 12:00 P.M. EST, SEPTEMBER 25, 2026, A LOCAL STATE OF EMERGENCY IS IN EFFECT IN THE VILLAGE OF SALTAIRE, AND THAT PURSUANT TO SECTION 34-4 OF THE SALTAIRE VILLAGE CODE, SUBJECT TO A VOTE OF THE BOARD OF TRUSTEES CONFIRMING THIS ORDER, THAT IT IS ORDERED THAT THE PUBLIC MEETING OF THE BOARD OF TRUSTEES AND ANY PUBLIC HEARINGS IF ANY TO BE CONDUCTED AT THAT PUBLIC MEETING PREVIOUSLY SCHEDULED TO BE HELD IN PERSON AT 103 BROADWAY, SALTAIRE, NEW YORK, SHALL BE HELD AS A VIRTUAL MEETING AND THAT THE CLERK OF THE VILLAGE OF SALTAIRE SHALL NOTIFY THE OFFICIALS OF THE VILLAGE AND PUBLIC AS SOON AS PRACTICABLE OF THIS DECLARATION AND ORDER, AND FURTHER;

THIS ORDER SHALL BE EFFECTIVE AT 12:00 P.M. DST SEPTEMBER 25, 2026 PURSUANT TO THIS DECLARATION BY THE HONORABLE MAYOR SUSAN SKERRITT. PLEASE TAKE FURTHER NOTICE THAT THIS ORDER SHALL BE IN EFFECT FOR A PERIOD OF 72 HOURS OR UNTIL FURTHER NOTICE.

PLEASE TAKE FURTHER NOTICE THAT ANY VIOLATION OF THIS EMERGENCY
ORDER OR OF ANY ORDER ISSUED HEREUNDER IS A CLASS B MISDEMEANOR,
WHICH MAY BE PROSECUTED BY THE VILLAGE TO THE FULL EXTENT OF THE LAW.
