AUTHORIZATION FOR PROCUREMENT OF A LIGHT DUTY UTILITY VEHICLE FOR THE SALTAIRE VOLUNTEER FIRE COMPANY (SVFC)

Mayor O'Brien provided an overview of the years-long process undertaken by the SVFC to design and publicly bid for the procurement of a utility vehicle to replace the current utility vehicle which has been in service for more than 25 years. Administrator Posillico provided the results of the November 7, 2024 bid for the light duty utility vehicle. After presentation by SVFC Chief Josh Raeben outlining the needs and functions that would be served by the replacement vehicle, and discussion amongst the members of the Board, which included the impact of the purchase on the overall capital project budget which would be partly financed with \$200,000 of the proceeds obtained through the most recent long-term bond issuance, and after all others having a chance to be heard, Trustee Wolf made the following motion:

WHEREAS, the Village is desirous of providing the SVFC with proper equipment to assist them in preparation for and responding to fire situations in the Village and within its mutual aid partners' districts; and

WHEREAS the Village of Saltaire solicited bids in compliance with the procurement policies of the Village of Saltaire for the procurement of a utility vehicle pursuant to the approved specifications; and

WHEREAS sealed bids were publicly opened at 11:00 a.m. EST on November 7, 2024, and Firematic Supply Company Inc., having been qualified by the Village Administrator as meeting all of the requirements of the bidding documents, is the certified low bidder for the procurement as specified in the bid documents and meets all the requirements stipulated in the bid;

THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Saltaire hereby authorizes the Village Administrator to declare Firematic Supply Company Inc. as the certified low bidder for the procurement of a utility vehicle pursuant to the approved specifications, and further,

BE IT RESOLVED that the Board of Trustees of the Village of Saltaire hereby authorizes the Village Administrator to execute the necessary contract documents with Firematic Supply Company Inc., as so approved by the Mayor in consultation with the Village Attorney, for the maximum contract amount of \$370,000.00 minus any reductions that the Village may achieve in negotiating the final contract, plus scope-of-work reductions, if any, plus the cost of any necessary change orders that the Mayor deems necessary and reasonable; and further

BE IT RESOLVED that the funding for the project for the approved amount shall initially be made from the Village's general reserves, with the general reserves to be repaid in whole or in part by any grant proceeds that are awarded, and any remainder to be repaid in whole or in part by the issuance of Bonds or Bond or Revenue Anticipation Notes, as previously authorized or to be authorized in the future.

DISCUSSION OF PROPOSED CODE MODIFICATIONS TO CHAPTER 55 (ZONING) AND AUTHORIZATION TO SET A DATE FOR A PUBLIC HEARING FOR CONSIDERATION OF ITS ADOPTION

Mayor O'Brien provided a summary of proposed changes to Chapter 55 (Zoning) to regulate roofs over decking, and further stated that such an amendment necessarily requires prior to adoption a determination of local authority from the Suffolk County Planning Commission, which had been requested but was not received prior to this meeting. The Mayor then sated that, assuming receipt of such determination from the County, it will be necessary to hold a public hearing on the proposed law at the next meeting of the Board of Trustees. Comments and questions were received from the members of the Board and those in attendance, and after all having a chance to be heard, Trustee Oppenheimer made a motion to hold a public hearing on the next scheduled meeting date to consider amendments to sections 2 and 14 of Chapter 55 of the Village Code in the final language submitted to Suffolk County Planning Commission.
