WHEREAS the Board of Trustees of the Village of Saltaire by resolution adopted on January 9, 2025 set a public hearing on the consideration of a Local Law of 2025 a Local Law Amending Section 55-2 and Section 55-14 of the Saltaire Village Code for February 27, 2025; and

WHEREAS the Board of Trustees of the Village of Saltaire by resolution adopted on January 9, 2025 preliminarily adopted lead agency status and further preliminarily determined that the consideration and adoption of the Local Law of 2025 was a Type I Action for purposes of SEQRA; and

WHEREAS the Board of Trustees thereafter timely served notification of the adoption of lead agency status and preliminary typing of the consideration and adoption of the Local Law of 2025 on the interested and potential necessary involved agencies as required by SEQRA; and

WHEREAS the Board of Trustees completed a Full EAF Part 1 and Part 2 and then made the referral of this local law to the Suffolk County Planning Commission and other parties required by the General Municipal Law, and the notice required by the New York State Village Law for a change of the Zoning Code, and the other notifications required by law; and

WHEREAS no comment or request was received by any other interested or potential involved agency with regard to the Board of Trustees serving as lead agency, or on the potential typing of the action as a Type I action for purposes of SEQRA comment on the referral of the adoption of the local law, or the potential impacts or notice of intention to adopt lead agency has been received by the Village of Saltaire and the Suffolk County Planning Commission notified the Board of Trustees that the Suffolk County Planning Commission determined that the consideration and adoption of the Local Law of 2025 is a matter for local determination; and

WHEREAS the Board of Trustees has reviewed the Full EAF Part 1 and Part 2 and the potential for significant negative impacts on the environment that may occur with respect to the adoption of the local law and corresponding changes in Section 55-2 and Section 55-14 of the Saltaire Village Code; it is therefore

RESOLVED that the Board of Trustees adopts Lead Agency status for purposes of SEQRA with respect to the consideration and adoption of the proposed Local Law of 2025 amending Section 55-2 and 55-14 of the Saltaire Village Code; and it is further

RESOLVED that the Board of Trustees hereby determines that the adoption of the proposed Local Law of 2025 amending Section 55-2 and Section 55-14 of the Saltaire Village Code is a Type 1 action for purposes of SEQRA pursuant to 6 NYCRR 617.4 due to the inclusion within or contiguous location of the affected properties with respect to a Federal parkland, the Fire Island National Sea Shore and it is further;

RESOLVED that the Village of Saltaire hereby determines that the adoption of the proposed Local Law of 2025:

Will not create a material conflict with any adopted land use plan or zoning regulations of the Village; and

Will not result in a significant change in the use or intensity of the use of land in the Village of Saltaire except the minor change of use or intensity of use permitted by the Sections of the Code amended by the proposed Local Law of 2025; and

Will not impair the character or quality of the existing community; and

Will not have an impact on the environmental characteristics that caused the establishment of a Critical Environmental Area; and

Will not result in an adverse change in the existing level of traffic or affect existing infrastructure for mass transit, biking, or walkways; and

Will not cause an increase in the use of energy or fails to incorporate reasonably available energy a conservation or renewable energy alternatives; and

Will not impact existing public or private water supplies; and

Will not impact existing public or private wastewater treatment facilities; and

Will not impair the character or quality of important historic, archaeological, architectural or aesthetic resources; and

Will not result in an adverse change to natural resources such as wetlands, waterbodies, groundwater, air quality, flora and fauna provided certain conditions are met on the development of the subject property; and

Will not result in an increase in the potential for erosion, flooding or drainage problems; and

Will not create a hazard to environmental resources or human health; and that it is therefore

RESOLVED that the adoption of the Local Law of 2025 will not result in a significant negative impact on one or more aspects of the environment and that a Negative Declaration is hereby adopted and shall be completed and filed as required for purposes of SEQRA.
